 Session 2: 1:00 P.M. – 4:00 P.M.

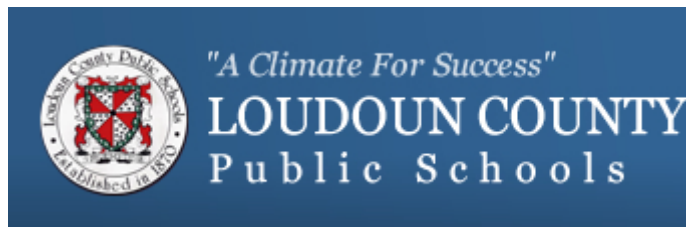
Cost: One class: \$700.00 (\$500 on-site fee plus \$200 processing fee)
 Two classes: \$1000.00 (\$800 on-site fee plus \$200 processing fee)

Repeat Classes

Students will need to complete at least 70 hours onsite to fulfill LCPS requirement. The following options are available:

- 1. One class: 12 full-time days (student attends both sessions)
Cost = \$600.00 (\$400 onsite fee plus \$200 processing fee)
- 2. One class: 23 part-time days (student attends one session)
Cost = \$700.00 (\$500 onsite fee plus \$200 processing fee)
- 3. Two classes: 23 full-time days (student attends both sessions)
Cost = \$1000.00 (\$800 onsite fee plus \$200 processing fee)

NOTE: Students must pay in full at the time of enrollment or set up an auto payment plan in order to receive the summer school rates.



Update on ED Anywhere and Summer Courses

ED Anywhere credits are accredited by SACS and Loudoun County Public School (LCPS) uses ED Anywhere to provide credit bearing courses for selected students.

LCPS has received assurance from ED Anywhere committing that all summer school classes that are repeated from failures in LCPS will include a minimum of 70 clock hours of classroom instructional time, at their site, taught by certified teachers.

No online course from unapproved sources will be accepted for credit.

LCPS will accept no more than two credits for summer school courses.

By July 16, 2007, ED Anywhere will confirm with LCPS office of Secondary Education the names of students who are enrolled in specific courses at that facility.

ED Anywhere course must be complete by the end of LCPS summer school session on August 13, 2007. Unofficial transcripts must be received by LCPS schools by August 24, 2007, with official transcripts arriving within a few weeks from their processing affiliate Home Study International.
